#### ARTICLE I. NAME

The name of the club shall be Lincoln Hills Tennis Group herein referred to as the "LHTG".

The name of the association is Sun City Lincoln Hills Community Association and herein referred to as "SCLHCA"

#### ARTICLE II. PURPOSE

1. The LHTG is organized and will operate in full compliance with the Association's governing documents, including the SCLHCA club Information & Guidelines Handbook.

2. The purpose of the LHTG is to provide Sun City Lincoln Hills residents the opportunity to participate in organized competitive and social functions.

#### ARTICLE III. MEMBERSHIP

Membership in the LHTG is open and restricted to all Association residents.

#### ARTICLE IV. MEETINGS

Members will be provided advance notice for the time and location of all LHTG general membership, social and Leadership Team meetings.

#### ARTICLE V. VOTING

The Leadership Team will be elected by the LHTGs general membership.

#### ARTICLE VI. RECORDS AND REPORTS

The LHTG is responsible for internal financial transactions and records, including any tax responsibilities, and has the responsibility to report appropriate financial business to its members.

- 1. All LHTG governing documents, meeting minutes, and financial records must be available for review by any LHTG member in good standing.
- 2. The LHTG will maintain a current list of at least two LHTG contacts with phone numbers and email addresses and submit it to the SCLHCA Room Booking and the SCLHCA Club Coordinator.
- 3. Lists containing LHTG member information shall not be used for commercial, political or personal purposes not related to the business of the LHTG.

#### ARTICLE VII. LHTG DISSOLUTION

In the event that the LHTG dissolves, all remaining assets will be either returned to LHTG members or donated to a charitable organization. Dissolution will not be initiated until all outstanding debts are satisfied. Upon dissolution or abandonment of recognized LHTG status, the LHTG should notify the SCLHCA Lifestyle staff of its reasons for dissolution or status abandonment.

#### **ARTICLE VIII. AMENDMENTS**

Bylaw amendments must be approved by the LHTGs general membership prior to being submitted to the CCOC for review and recommendation to the Association's Board of Directors for approval. They will become effective after final approval by the Association's Board of Directors (BOD).
